What are PPCPS?


PPCPS or Pharmaceuticals and Personal Care Products



PPCPs


- Prescriptions





Effects of PPCPs


- Exact effects are unknown, however the research is still underdeveloped.

Urban PPCP Sources


- Sewer Systems

Rural PPCP Sources

- Septic Tanks
- Agricultural Runoff



College towns

- •Can encompass elements of both Rural and Urban centers.
- •Fluctuating water rates



Example: DeKalb, IL

- Northern Illinois University
- Consistent year round water use
- •Elevated contaminant levels during Fall, Winter, and Spring Months



PPCPs: FDA stance

- Originally FDA stance on leftover drugs was to flush them down the Toilet.
- Trace amounts of PPCPs began to appear in surface bodies of water.
- FDA still has the stance that powerful narcotics(Morphine, Nicotine Patches) should be flushed because of the strength of these drugs.

What an individual can do to help

- Properly dispose of Prescriptions
- Use Personal Care products that do not have harsh chemicals
- Conserve use of PPCPs

Properly disposing of Prescriptions

- Follow any specific instructions on the drug (eg, needles) that accompanies the drug.
- Use community drug take back programs, contact your cities trash and recycling service for more information on specific towns
- If no instructions given on the medication, mix the drug in with an undesirable substance
- Place mixture into a sealable bag and the drug can be disposed of in household trash
- Do not flush prescriptions down the toilet!

What Farms can do to prevent PPCP contamination.

- Use waste collection barrels.
- Cover them to prevent run-off
- •Keep better track of Septic Tanks and Drainage tiles



What Cities can do to prevent PPCP contamination

- •Reduce leakage from municipal sewer systems.
- Add tertiary testing and treatment systems
